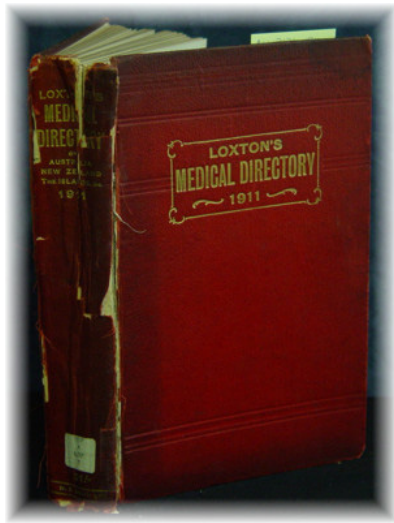

## PRINCIPLES OF MEDICAL ETHICS

*A Suggestive and Advisory Document.*

---

### THE DUTIES OF PHYSICIANS TO THEIR PATIENTS.

SECTION 1. Physicians should not only be ever ready to obey the calls of the sick and injured, but should be mindful of the high character of their mission and of the responsibilities they must incur in the discharge of momentous duties. In their ministrations they should never forget that the comfort, the health, and the lives of those intrusted to their care depend on skill, attention and fidelity. In deportment they should unite tenderness, cheerfulness, and firmness, and thus inspire all sufferers with gratitude, respect and confidence. These observances are the more sacred because, generally, the only tribunal to adjudge penalties for unkindness, carelessness or neglect is their own conscience.

SECTION 2. Every patient committed to the charge of a physician should be treated with attention and humanity, and reasonable indulgence should be granted to the caprices of the sick. Secrecy and delicacy should be strictly observed; and the familiar and confidential intercourse to which physicians are admitted in their professional visits should be guarded with the most scrupulous fidelity and honour.

SECTION 3. The obligation of secrecy extends beyond the period of professional services; none of the privacies of individual or domestic life, no infirmity of disposition or flaw of character observed during medical attendance should ever be divulged by physicians, except when imperatively required by the laws of the State. The force of the obligation of secrecy is so great that physicians have been protected in its observance by courts of justice.

SECTION 4. Frequent visits to the sick are often requisite, since they enable the physician to arrive at a more perfect knowledge of the disease and to meet promptly every change which may occur. Unnecessary visits are to be avoided, as they give undue anxiety to the patient; but to secure the patient against irritating suspense and disappointment the regular and periodical visits of the physician should be made as nearly as possible at the hour when they may be reasonably expected by the patient.

SECTION 5. Ordinarily, the physician should not be forward to make gloomy prognostications, but should not fail on proper occasions to give timely notice of dangerous manifestations to the friends of the patient, and even to the patient if absolutely necessary. This notice, however, is at times so peculiarly alarming when given by the physician that its deliverance may often be preferably assigned to another person of good judgment.

SECTION 6. The physician should be a minister of hope and comfort to the sick, since life may be lengthened or shortened, not only by the acts, but by the words or manner of the physician, whose solemn duty is to avoid all utterances and actions having a tendency to discourage and depress the patient.

SECTION 7. The medical attendant ought not to abandon a patient because deemed incurable, for continued attention may be highly useful to the sufferer and comforting to the relatives, even in the last period of the fatal malady by alleviating pain and by soothing mental anguish.

SECTION 8. The opportunity which a physician has of promoting and strengthening the good resolutions of patients suffering under the consequences of evil conduct ought never to be neglected. Good counsels, or even remonstrances, will give satisfaction, not offence, if they be tactfully proffered and evince a genuine love of virtue, accompanied by a sincere interest in the welfare of the person to whom they are addressed.

# AUSTRALASIAN TRAINED NURSES' ASSOCIATION

(A.T.N.A.)

THE Association was founded in the year 1899, and its objects were briefly set forth as follows :—

- (1) To promote the interests of Trained Nurses—male and female—in all matters affecting their work as a class.
- (2) To establish a system of registration for Trained Nurses.
- (3) To afford opportunities for discussing subjects bearing on the work of Nursing.
- (4) To initiate and control schemes that will afford to Nurses a means of providing an allowance during incapacity for work caused by sickness, accident, age or other necessitous circumstances.

Some alterations in the Rules of the Association were made late in the year with a view of more precisely determining its constitution and management, and of defining the qualifications necessary for registration ; and also with a view of admitting to registration and to the membership of the Association Nurses who, although they could not produce certificates of hospital training, were able to show, to the satisfaction of the Council that they had been engaged for not less than three years in the *bona fide* work of Medical and Surgical Nursing and could produce certificates of competency and good conduct.

It was decided that applications under the amended rules might be made up to March 31st, 1900. During the closing months of 1899 and the early months of the current year, the Council were much occupied in considering and dealing with applications for registration under Rules 18, 19, 20 and 21, and the publication of the Register has thus been delayed. The Council, either as a body or by means of a sub-committee appointed for the purpose, has carefully investigated the credentials of every applicant for registration, and by its rules has power of removing from the Register the name of any Nurse who, after full enquiry, may hereafter prove herself to be unworthy of trust.

The Register, therefore, is of interest to the general public as affording a means of distinguishing between Nurses who are qualified by training and experience to undertake the work of skilled nursing, and those who are without these qualifications. The Committee of the Royal British Nursing Association has well pointed out that “by means of such a Register the public is protected against unskilled and untrustworthy nursing.”

The number of qualified Medical Practitioners who have joined the Association as members, is a guarantee of the interest which is taken in the Association by the members of the Medical Profession.

It has been deemed advisable to print the rules of the Association in the front of the Register as being in a measure explanatory thereof ; but it is necessary to point out that the only rule under which Nurses can now (subsequent to March 31st, 1900) be registered is Rule 18, which is as follows :—

(xviii.) Candidates for registration must produce proof—

- (a) That they have been engaged for three years in general Hospitals recognised by the Council and containing not less than 40 beds ; or
- (b) That they have been engaged for four years in a country, district, or suburban Hospital recognised by the Council and containing not less than 20 beds, and have been trained at that Hospital under a Matron or Nurse who holds a certificate from a Training School for Nurses recognised by the Council of this Association ; or

# HOW TO BECOME A DOCTOR IN AUSTRALIA

## MATRICULATION.

1.—Candidates for any of the degrees granted by the University shall be required to matriculate before entering upon the prescribed course.

2.—Candidates before being admitted to matriculation shall have passed one of the examinations required by the By-laws for admission to the prescribed courses in the different faculties, or shall have been admitted *ad eundem statum*.

3.—Undergraduates of other Universities may, at the discretion of the Professorial Board, be admitted *ad eundem statum* in this University without examination. Provided always that they shall give sufficient evidence of their alleged *status* and of good conduct.

4.—Any person desirous of attending University lectures may do so without matriculation upon payment of such fees as the Senate may from time to time direct.

Candidates for matriculation are required to pass a satisfactory examination in Latin, Arithmetic, Algebra, Geometry, and one of the following subjects—Greek, French, German. Proficiency in writing English is also taken into account.

The conditions of admission to the Medical School will be found in section 7 of the By-laws relating to the Faculty of Medicine hereunder.

## TERMS.

The Academic year shall contain three terms, that is to say :—

*Lent Term.*—Commencing on the tenth Monday in the year and terminating with the Saturday before the twenty-second Monday in the year, with a recess at Easter not exceeding nine days.

*Trinity Term.*—Commencing on the twenty-fourth Monday in the year and terminating with the Saturday before the thirty-fourth Monday in the year.

*Michaelmas Term.*—Commencing on the thirty-ninth Monday in the year and terminating with the Saturday before the fifty-first Monday in the year.

## FACULTY OF MEDICINE.

1.—The Chancellor and Vice-Chancellor, the Fellows of the Senate who are legally qualified members of the Medical Profession, and the Professors and Lecturers in the subject of the Medical curriculum shall constitute the Faculty of Medicine.

2.—The Dean shall exercise a general superintendence over the administrative business connected with the Faculty, and it shall be the duty of the Registrar to summon meetings of the Faculty at such times as may be required by the Dean, provided that upon the written requisition of any three members of the Faculty, the Dean, or in his absence the Registrar, shall convene a special meeting. No question shall be decided at any meeting of the Faculty unless there be present at least five members. In the absence of the Chancellor and Vice-Chancellor the Dean shall act as Chairman at all meetings of the Faculty, but in his absence the members then present shall elect a Chairman from among themselves. The Chairman at any such meeting shall have a vote, and in case of an equality of votes, a second or casting vote. It shall be the duty of the Registrar to attend all meetings and to record the proceedings.

3.—The Faculty shall meet for the purpose of considering and reporting to the Senate upon such subjects as have relation to the studies, lectures, examinations and degrees in Medicine, and such questions as may be referred to it by the Senate.

4.—Class Examinations shall be held during each course of instruction in each term, unless such term immediately precedes the annual examination in the subject of the course. Students shall not absent themselves from these examinations except upon a medical certificate, and at the end of each course a report of the result, signed by the responsible teacher, shall be presented to the Senate by the Dean. The results of these examinations may be taken into account by the examiners at the annual examinations.

5.—There shall be three Degrees granted in the Faculty of Medicine, viz. : Doctor of Medicine (M.D.), Bachelor of Medicine (M.B.), and Master of Surgery (Ch.M.).

6.—Candidates for a Degree in Medicine shall, before admission to the Medical School, produce evidence of having graduated in Arts or in Science, or of having attended the

## Navigating Archive CD Books CDs

---

All Archive CD Books products can be navigated easily using the handy bookmarks on each CD. The table of contents in most original books, and the original book index where it exists, can provide additional ways of finding the information required.

## Searching Text on Archive CD Books Australia CDs

---

Optical Character Recognition (OCR) technology has been developing over the years as a useful mechanism to convert images (as Archive CD Books pages are) into text which can be searched. The quality of the OCR can still vary, and hence the searchability can vary. Around 95% or 99% of the words in books with good type are searchable—or even higher with very good type.

*OCR is now a wonderful searching aid in many instances  
but there is still no substitute for reading the book!*

## Different Versions of Adobe Acrobat Reader

---

Adobe Acrobat Reader 4 or later should be used. Adobe Reader 6 (as it is now named) in fact has considerably better searching options and is recommended.

- **Acrobat Reader v4** has both a “Find” and a “Search” tool. Those tools are two *\*totally\** different things. Our CDs (that are searchable) work with the *\*FIND\** tool
- **Acrobat Reader v5** has only a “Find” tool (not a “search” tool). Our CDs (that are searchable) work with the *\*FIND\** tool.
- **Adobe Reader v6** has only a “Search” tool (not a tool labelled “Find”). HOWEVER — what is called “Search” is the same as the tool that used to be called “Find” Our CDs (that are searchable) work with the *\*SEARCH\** tool

## Tips For Searching and Getting More From the CD Books

---

- update to Adobe Reader 6 for more versatile searching options, including the ability to bring up a list of all instances of the word you are searching for — across multiple files on a single CD in a single search request.
- enter the MINIMUM number of characters needed to bring up the search results required.
- use Adobe Reader 6 to do some trial searches to try to identify the characters that may be misread. These can show up in the extra text in the search results list (Adobe 6 only). A few minutes trial will help you to avoid using characters that are more prone to being misread, e.g. try entering “rederi” if you want “Frederick”, but find that the letters “F” “c” and “k” are sometimes misread.
- use the “Match whole word” option to eliminate unnecessary items in your results list, e.g. to eliminate all the blacksmiths and tinsmiths etc when you only want the name Smith.
- use the “Match case” option to eliminate all the occupations “smith” if you only want the name “Smith”.
- don’t just search for names. Search the book for other names, places and subjects of interest:
  - › look for others of the same name
  - › look for others who lived in the same place or street
  - › who was the postmaster or police officer in the town?
  - › how often and at what time did the coach arrive in town?
  - › what churches were there and what time were services held?
  - › what other activities were there in the community?
  - › look for others who had the same occupation or other interests
- all of this and more may be available in a seemingly mundane book such as a directory. You can learn much of the background of life at the time, even if your ancestor is not listed there.
- Many CDs have only one file, but some have the book content spread over several files. Adobe Reader normally searches in the file that is open at the time. If you wish to search ALL files at once choose the “All PDF documents in” option and select the CD drive or directory the files are in—Adobe Reader 6 only.
